We Continue to Grow

RSVP...where volunteers make a difference

The theme for the 2023 annual report is *We Continue to Grow!* This past year was also a year of transition. Margie Zutter, the Executive Director, retired in August after 46 years with RSVP. I moved from Assistant Director to Executive Director and Kate Seal, the Group Projects/Homeworkers Program Coordinator, became Assistant Director. As COVID-19 slowed down, more volunteers were able to transition back to helping inperson, such as driving clients to medical appointments and tutoring students in a classroom. I am very excited about my new role at RSVP. I have learned a lot in the last few months and I look forward to working with staff, the Board, and all of our wonderful volunteers and partners as RSVP Continues to Grow!

Highlights from 2023:

- Still short on volunteers from the COVID-19 pandemic and faced with an increasing demand for rides to medical appointments, the Driver Services and VHV staff started working on a large marketing campaign to recruit more drivers. The campaign included television and streaming commercials, written media, radio ads, and tabling events at focal points and health fairs.
- For the first time in four years, all Foster Grandparent volunteers could tutor and mentor in person in classrooms in Dane County.
- In November, RSVP held a Veterans Day event at the new VFW Post 1318 in Madison. Kevin Hampton, WI Veterans Museum curator, gave a presentation about veterans from WI who served in WWI. A total of 49 participants attended this talk either in person or virtually via Zoom.
- "Country Cool" was the theme for RSVP's 51st Annual Volunteer Appreciation event at Barnwood Events in Madison. Over 200 volunteers, volunteer station representatives, funders, and sponsors attended this fun event. Guest speakers from the Bureau of Aging and Disability Resources at the Wisconsin Department of Health Services were Timothy Wellens, Regional Quality Specialist, and Samantha Margelofsky, Volunteer Program Coordinator, who spoke about the health effects of social isolation and loneliness. They discussed the role volunteering plays in decreasing feelings of loneliness and isolation for both the volunteer and the recipient.
- In remembrance of September 11, 2001, RSVP hosted an annual donation drive-thru event to help struggling neighbors in our community. RSVP staff and volunteers collected food and essentials for the Social Justice Center's resource pantry.
- RSVP contracted with The People Company to perform a Diversity, Equity, Inclusion and Anti-Racism (DEIAR) Assessment. The People Company conducted this assessment through individual interviews, focus group sessions, and a survey of volunteers and staff. Focus Group participants included RSVP volunteers, Senior Center/Outreach Services staff, and community members. Results of this assessment with their suggestions (DEIAR Report 1/31/23) were presented to the Diversity Committee, Board, and Staff in March of 2023. At the April Board meeting, RSVP's Diversity Committee suggested that the RSVP Board create a new strategic vision which will include new equity recommendations from this report.
- The 21st Triad Conference was held on October 20th at the American Family Insurance Training Center in Madison. This was the first time in four years, due to the COVID-19 pandemic, that we were able to hold the conference in person rather than virtually, and it was a great opportunity to meet, network, and learn. The Wisconsin State Health Plan Coordinator, Margarita Northrup, gave the keynote address, *Health and Wellbeing in Retirement: Understanding Civic Engagement and Health*. Over 115 participants, presenters, and exhibitors from around Wisconsin attended.

Looking back at 2023, volunteers were able to serve more hours (151,632) in 2023 compared to 2022 (143,211). An increased number of volunteers in each of our programs were able to start to serve in person. Volunteers who could not be in person, continued to help their community through virtual opportunities. We appreciate the many ways RSVP and FGP volunteers helped others during the pandemic. We thank all our volunteers who were able to serve safely!

HISTORY, MISSION, VISION, AND INCLUSION STATEMENT

HISTORY

In 1969, the Retired and Senior Volunteer Program (RSVP) was created as a national volunteer program under the Administration on Aging as part of the Older Americans Act. In 1971, eleven programs were launched, and they became part of the national volunteer agency ACTION (now the Corporation for National and Community Service-AmeriCorps Seniors programs.)

In 1972, we became the first RSVP program in Wisconsin and then in 2000, added a Foster Grandparent Program (FGP). Today, 170,000 AmeriCorps Seniors volunteers in RSVP, FGP, and Senior Companion programs serve nationwide. With over 1,200 volunteers, RSVP of Dane County is one of the largest AmeriCorps Seniors programs in the United States.

MISSION

To make a positive impact in the community by recruiting volunteers 55 and older to help deliver priority services to people of all ages, providing Dane County with a valuable resource.

RSVP seeks to:

- utilize the skills, knowledge, and life experiences of people who are retired, helping them to lead healthy, productive lives;
- respond to increasing requests for volunteers to help meet critical needs;
- increase the variety of volunteer opportunities;
- provide opportunities for intergenerational projects and age-integrated activities;
- plan programming in cooperation with the groups, agencies and institutions with which it is involved, as needed and requested;
- involve volunteers in planning and decision-making on community programs, boards, and committees;
- increase public awareness concerning contributions and needs of people age 55 and older, and improve the image of aging.

RSVP aspires to build and expand a community-wide network of volunteers and organizations that unite compassionate, experienced adults with meaningful and fulfilling service opportunities, which enrich the lives of the volunteers while enhancing support for people in need.

WHO WE ARE/VOLUNTEERS IN SERVICE

RSVP seeks to utilize the skills, knowledge, and life experiences of older adults, helping them lead healthy, productive lives while making a positive impact in the community. RSVP volunteers provide direct service, helping a wide variety of public and nonprofit organizations in Dane County. What makes RSVP so unique? Volunteers are personally interviewed and matched with appropriate assignments that meet their time, interest, and lifestyle needs, as well as skills required by community agencies. We also provide regular follow-up to ensure volunteer satisfaction. Survey results indicate that over 94% of RSVP volunteers feel their volunteer work keeps them active, and that they have a more positive outlook because they help their community.



RSVP's Group Projects/Homeworkers volunteers share their sewing, knitting, and crocheting talents to create quilts, shawls, afghans, and other items of warmth and comfort. They also make tote bags, walker and wheelchair bags, chemo caps, fidget quilts, and a variety of other useful specialty items. All of these handcrafted goods are then distributed to local nonprofit and public agencies, to be given to those in need.

Foster Grandparent

Program





Foster Grandparent Program volunteers serve between 5 and 40 hours per week and providing one-on-one support for students, teachers, and classrooms in Dane County schools and Reach Dane Head Start sites. Foster Grandparents are an integral part in improving academic performance and social skills, resulting in increased student engagement for improved school readiness and success. While much of the Foster Grandparents' time is served in person, remote student academic and skills attainment support is provided to emerging writers through the Postcard Pen Pal program. Foster Grandparents have continued to deepen their knowledge and explore new avenues of student support through quarterly inservice trainings as well engaging one another in topic discussions in Book and Movie Clubs. Income eligible adults age 55+ receive a tax free stipend, meal, and travel reimbursement for their service.







Intergenerational volunteers provide the presence of an additional adult allowing the added attention needed to increase student confidence in learning.




